

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to the www.globallounge.org and Global Lounge and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Global Lounge include www.globallounge.org, World Village and <http://www.worldvillagefestival.com>. The Global Lounge website is a Community Education site. By using the Global Lounge website, you consent to the data practices described in this statement.

Collection of your Personal Information

Global Lounge may collect personally identifiable information, such as your name. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by Global Lounge. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Global Lounge website.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Global Lounge's public message boards, this information may be collected and used by others.

Global Lounge encourages you to review the privacy statements of websites you choose to link to from Global Lounge so that you can understand how those websites collect, use and share your information. Global Lounge is not responsible for the privacy statements or other content on websites outside of the Global Lounge website.

Use of your Personal Information

Global Lounge collects and uses your personal information to operate its website(s) and deliver the services you have requested.

Global Lounge may also use your personally identifiable information to inform you of other products or services available from Global Lounge and its affiliates. Global Lounge may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

Global Lounge does not sell, rent or lease its customer lists to third parties.

Global Lounge may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Global Lounge, and they are required to maintain the confidentiality of your information.

Global Lounge will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Global Lounge or the site; (b) protect and defend the rights or property of Global Lounge; and, (c) act under exigent circumstances to protect the personal safety of users of Global Lounge, or the public.

Use of Cookies

The Global Lounge website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Global Lounge pages, or register with Global Lounge site or services, a cookie helps Global Lounge to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same Global Lounge website, the information you previously provided can be retrieved, so you can easily use the Global Lounge features that you customized.

You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. If you choose to decline cookies, you may not be able to fully experience the interactive features of the Global Lounge services or websites you visit.
